In accordance with Chapter 91, Section 142, Revised Statutes of 1954, and at your request, we have audited the records of the Town of Franklin for the period March 1, 1958 to March 1, 1959.

The examination was made in accordance with generally accepted auditing standards that pertain to municipal accounting. Audit analysis was on a basis consistent with that of the preceding year, and included all procedures which were considered necessary. Insofar as could be ascertained within the scope of the examination the financial transactions of the Town appear to have been appropriately handled.

Exhibits and Schedules incorporated in this report impartially present the financial position

of the Town and the result of its operations for the period designated.

Comments and other data included in the report may prove of interest to you, all of which is respectfully submitted.

COMMENTS

An audit has been completed of the financial records of the Town of Franklin for the fiscal year ended March 1, 1959. This audit included an examination of the records maintained by the Assessors, Selectmen, Treasurer, Tax Collector and Town Clerk.

The examination included a review of cash transactions, as well as an analysis of available funds and expenditures. The results of the year's operation of the departmental accounts revealed that available funds exceeded expenditures by \$4,634.23.

ASSETS

The cash balance of \$6,599.04 was reconciled with the bank statements furnished by the Union Trust Company, Ellsworth, Maine. A count of cash was made at date of audit, and reconciled with the closing balance at March 1, 1959.

Other assets, including accounts receivable, taxes, tax liens and tax acquired property were reviewed. Unpaid accounts were reconciled with the balances shown on record of the Selectmen.

LIABILITIES

Total general fund liabilities amounted to

\$1,598.24 which represented notes payable of \$1,500.00, accounts payable of \$2.41 and due trust funds \$102.83.

RESERVES AND SURPLUS

The appropriation accounts reflect a net unexpended balance of \$145.84 which are being carried forward to the ensuing year.

The unappropriated surplus amounted to \$7,-767.88, an increase of \$2,968.16. This change was occasioned principally by the excess of available funds over expenditures less several transfers to departmental accounts.

TRUST FUNDS

An examination of the various funds held in trust by the Town revealed that the principal and income from these funds were legally invested, with the exception of \$102.83 due from the general fund.

SCOPE OF AUDIT

Count of cash was made and records checked to determine the accuracy of recording cash transactions. The system of internal control was reviewed as pertained to the handling of cash and other matters of financial concern. Receipts, vouchers and cancelled checks were examined for a selected period and major increases or decreases

in revenue or expenditures over previous years were explored.

Various laws pertaining to the fiscal operations of the municipality were reviewed to determine that related financial transactions were properly administered.

Included in this report are exhibits and schedules pertaining to the financial status of the Town. Audit procedures were followed to the extent deemed necessary to develop these statements.

It is believed that the accompanying balance sheet and supporting statements fairly present the financial position of the Town at March 1, 1959 and the result of its operations for the year then ended.

We have the same faculty this year as last and the school has been progressing as well as any small school. Mr. Forni continues to provide excellent leadership for school and all teachers are following the prescribed course of study. We can be proud that several of our students are on the honor roll at High School, and Franklin is also represented favorably in Extra-Curricular Activities.

Last summer we made some essential repairs to the building and replaced worn-out black-boards. We also installed thermostats in two rooms and motorized valves which gives much more even heat through-out the building and should conserve on fuel.

We have finally worked off the over-draft of several years standing and are pleased to report a substantial balance with all bills paid. The Financial Statement for last year follows together with the proposed budget for next year. The above budget represents increases for teachers, whether they be the same personnel or new positions. The sizeable portion of the increased budget is due mainly to approximately \$4500 more needed for secondary tuition. This is occasioned by only four Seniors graduating with ten more entering High School in the Fall.

We anticipate state subsidy next year in the amount of \$15210 which with our balance of \$1875.67 gives us a total estimated receipts of \$17085.67. Our budget is estimated at \$38205., a difference of \$21119.33. We, therefore, recommend for all school purposes an appropriation of \$21200 and an additional \$500 for repairs which must be raised separately.

In closing I would again thank the Committee and other Town Officers for all their help during the year. I would feel this report incomplete if I did not also commend the teachers, janitor, bus drivers, and school lunch personnel for their part in the program.


